- 12. Detail the differences between section A on page 17 and section B on page 18.
- 13. Do you see how section A may receive an unsuccessful score on the AP Exam while section B may be successful? Explain why or why not.

Paragraph 13

14. One problem I believe students have in mastering academic skills is transferring knowledge from one thing to another. This may be a lack of connection from one class to another (e.g. using the skills you are learning in AP Language for your written responses in AP Government), or from one unit to another in the same class. What idea from Chapter 2 does this paragraph reinforce? If you have to go back to Chapter 2 to figure this out, that is a sign that you are not internalizing what you are reading.
